

Graham Hancock Plagiarism

The Scam

I cannot be complacent any longer. Graham Hancock has hijacked an especially important and unique pillar of my lifelong work. Graham Hancock has blatantly plagiarized me. Yes, getting these words out has been a challenging decision, but the time has come.

In my books, Heretical Wisdom – the Truths from Within (2001) and Alpha to Omega – Journey to the end of Time (2012), each with the same core foundation, is exactly that which Hancock has claimed for his own. The survivors of an advanced civilization – eradicated in the biblical flood – are actually the renowned mythical gods of ancient lore from all over the world. For thousands of years, they mentored the people of our new epoch and assisted them in the construction of the magnificent ancient megaliths found on every continent.

In his book, Magicians of the Gods (2015) and his Ancient Apocalypse (2023-24) Netflix multi-part documentary, he claims an advanced civilization wiped out by a cataclysmic flood whose survivors were the gods of ancient lore. These gods aided the people of the world in the construction of the many ancient megaliths around the world.

Alpha to Omega – Journey to the end of Time is a new and timeless paradigm, which provides readers with unique and unprecedented perspectives on several long-accepted tenets of history, science, and religion. Alpha to Omega is a revolutionary journey through time and meaning. The foundation upon which it rests is exactly what Hancock has usurped.

Alpha to Omega is more than an idea. The foundation itself is a brand new perspective or paradigm, but Hancock leads us on a road to nowhere. Alpha to Omega reveals much more in the evaluation of **my** discovery. It is the cornerstone of a remarkable philosophical theory that reconciles the disputes between religion, history and science. Hancock's deliberate theft, coupled with his popularity, has caused a major detour for curious readers who may never get a chance to discover Alpha to Omega – Journey to the end of Time.

To be forthright and clear, Hancock had **never** correlated the mythical gods of ancient history as anything more than just myths. He was as blind to it as everyone else. Ask yourself, did you ever hear of that before? He had no answers until he read my book three years prior to his release of Magicians of the Gods (2015).

I had heard of his new book and in 2016, I attended the annual *Contact in the Desert* conference in Joshua Tree, CA. I knew he was going to be there, which is the only reason I attended, because I was hoping to confront him and to receive his public admission.

Prior to his presentation, I approached him in the auditorium. He was extremely coy. As soon as we met eye to eye, he asked, "Have we met before?" I knew right away that he was guilty because he knew for sure we never met. I had been discussing my book on Facebook with several of his friends. I answered, "No, but I sent you a PDF copy of my book." Without any response, he turned his eyes away and asked if I had a copy of the book with me. Of course, I had a copy, which I gave him with my signature. That was it and he turned away. I didn't know what else to say. I was hoping for at least one mention in his presentation.

About a half-hour later I watched his ninety minute presentation from the 20th row. He was the most interesting person in the entire event and his presentation stunned the audience. He received an amazing reception and applause. But I was upset beyond words. It was a kick in the gut. I had to fight off my tears while everyone else was clapping.

I had spent my entire adult-life researching and **merging** a variety of scientific, historic, and religious teachings to support and complete the Alpha to Omega paradigm. I really believed that Hancock must have discussed this with his attorney before releasing Magicians of the Gods and thus, I felt handcuffed and defeated. It's a perfect example of David vs Goliath.

He never acknowledged me, nor did he contact me. Instead, his theft of my intellectual property put him back in the spotlight. He has benefited by unlawfully claiming my ideas as his own. He took further steps to create a Netflix Series: Ancient Apocalypse, which was a video creation of Magicians of the Gods and debuted in January of 2023. The second season aired in January of 2024.

Upon his first season's release of his Netflix documentary, Ancient Apocalypse, I posted this on my Facebook pages on January 10, 2023. It is still pinned to the top of all four of my pages. I felt defeated in 2016, but the Netflix show was a knife in my heart! I had to do something.

I know you have read my book, just like Gary Osborn, Robert Bauval, and John Anthony West, who mocked me when I claimed the GP to be MUCH older than the prevailing narrative. In Alpha to Omega, only one solution for the Great Pyramid's function answers all the questions. It is one of two axioms needed to solve all these mysteries while exposing human potential beyond our current imaginations. Axioms are representative of a theory.

After all, a valid theory is an evaluation of evidence designed to answer many questions and leave as few on the table as anyone else can and I had beat you to it. You obviously felt as though you had the right to present this as yours - and without acknowledgment to boot. Your ego is getting in the way.

Please explain how the advanced civilization lifted huge megalithic structures weighing tons and carried them up steep mountains? No tools have been found nor written documents. I gave my solutions to that and much more, in my book, Alpha to Omega - Journey to the End of Time. I wasn't afraid to be mocked by those who disagree or find it nearly impossible to believe. And now you're introducing the possibility of new realities when that was thoroughly discussed in Alpha to Omega.

You claim that the Great Pyramid is approximately 4500 years old. How can you, in your right mind, assess that the GP post-dates the mesmerizing sites you've investigated in Fingerprints and Magicians? The importance here is not just my theory, but proof that you have usurped the first part of MY theory and are now alluding to things I've already explained - without a single mention of my work.

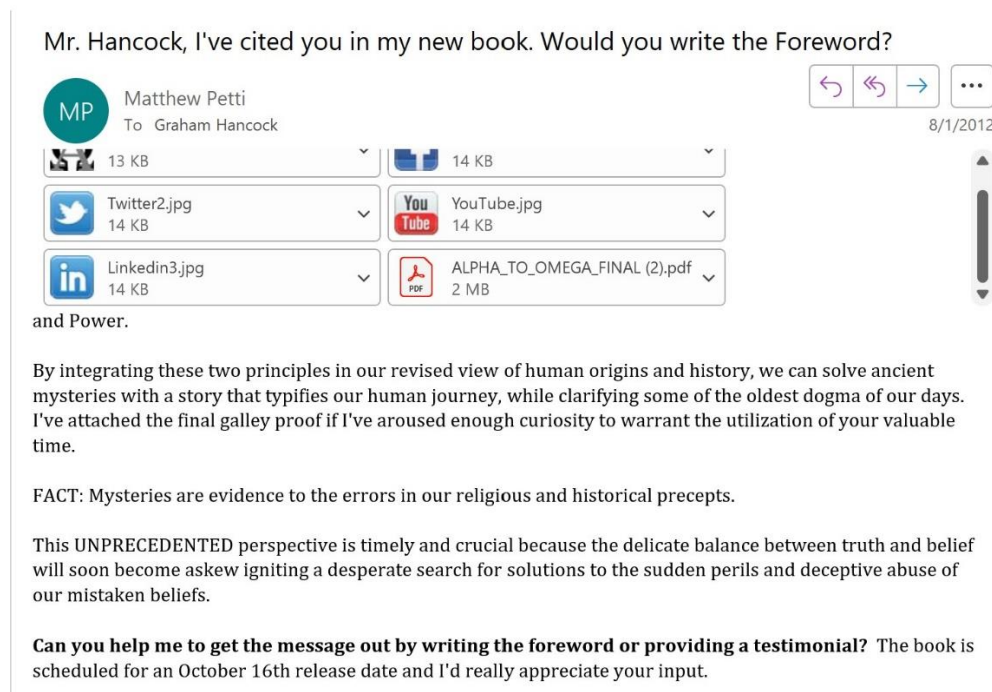
My theory is sacred and extremely important. It is timeless, because it creates an entirely new paradigm that solves the mysteries of history and religion while cleverly evaluating evidence of quantum experiments as the visual effect of the total possible combination of conscious choice at any fraction of a second - rather than the cause of a multiverse with different outcomes.

It really bothers me that you are diluting the entire meaning of an important and timely story. In fact, my first book published in 2001 - Heretical Wisdom - embraced the same theory. Where were you then?...

During the days before my release of Alpha to Omega, Graham Hancock had recently finished a fiction novel titled Entangled (2010) and was working on his 3-book series titled War God, which were fiction novels centered on the ancient mythical gods of South America. He had been well-over fifteen years removed from Fingerprints of the Gods, when he was admittedly clueless regarding the relation to mythical gods and the ancient megaliths across the world. He hadn't produced another ground-breaking book – until Magicians of the Gods. The problem here is that he wasn't the one who broke the ground!

His War God trilogy clearly relayed his stance that these were merely myths garnered by tales from all parts of the world. Myths can only lead to the birth of fiction novels. He can say whatever he wants. He has plagiarized me and here is the Truth. He cannot claim otherwise.

It was on August 1, 2012 that I reached out to him by email with a PDF copy of my book, Alpha to Omega – Journey to the end of Time, only one month prior to its release. I had referenced Fingerprints of the Gods several times in my book and asked if he would kindly write a short foreword. I never received a response or a kind gesture from him, so I didn't think anything about it. This screenshot was included in my Facebook posts as well.




He was oblivious in his regards to the “mythical gods” and to the hundreds of similar tales of floods, devastation, and a new epoch. Will those who follow Graham balk at taking a closer look at my work? How many will **improperly** assume that I plagiarized Mr. Hancock?

This from p. 23 of Alpha to Omega is a quote from Hancock, Fingerprints of the Gods p.199:

We are on a trail of mystery here. And while
we may never hope to fathom the plans of the
Creator, we should be able to reach judgment
concerning the riddle of our converging myths
of global destruction. ²

Think about this. Why would I have any reason to solicit his support, if his work, in any way, espoused a similar notion? Meanwhile my discovery wasn't merely a notion at that time. It had become a major pillar of my philosophical theory. Where did we come from? What is our purpose? What is our destiny?

Within weeks Hancock halted his work on the third part of his Trilogy and began his work on Magicians of the Gods. Here he mentions the third part of the Trilogy to be titled “Apocalypse” and to be released in 2016. However, the third part was titled “Night of Sorrows” and published in July of 2018. To me it demonstrates his frantic attempt to release Magicians of the Gods as quickly as possible along with America Before – the key to Earth's lost Civilization (2019), which I will explain later.

basic characters, dilemmas and plot of the book that would become my first novel, *Entangled*, published in 2010. *Entangled* tells the story of two young women, one living 24,000 years ago in the Stone Age, and the other in modern Los Angeles, who are brought together by a supernatural being to do battle with a demon who travels through time.

Since the publication of *Entangled* I have also written the first two volumes of a series of three epic novels about the Spanish conquest of Mexico - the War God trilogy. The first volume, *War God: Nights of the Witch*, was published in 2013, and the second volume, *War God: Return of the Plumed Serpent*, was published in 2014. The third volume, *War God: Apocalypse*, is already more than half written and will be completed in 2016 and in the meantime my new non-fiction book, *Magicians of the Gods*, was published on 10 September 2015. *Magicians* is the sequel to *Fingerprints of the Gods*, and presents all the new evidence that has emerged since 1995 for a great lost civilisation of prehistoric antiquity and for the global cataclysm that destroyed that civilisation almost 13,000 years ago - a cataclysm on such a scale that it forced mankind, as Plato put it, “to begin again like children with no memory of what went before.”

For many years, including the year 2012, Graham had been publicly seeking authors to remit their works and, to those deemed notable, he would reward them with his recognition. How much information has he pilfered in his attempt to provide solutions to his unanswered questions? He has obviously employed several people who work on the acquisition and collation of significant material.

Unfortunately for me and my potential readers, Mr. Hancock has forced a detour by plagiarizing a cornerstone of the Alpha to Omega theory. He leads his followers on a dead-end journey with careless intimations of the biblical flood and the survivor gods. That's a major detour to meaningful and timely information. Hancock's condescending ego-centric theft of my crucial premise needs to be publicly revealed and paid for.

The Backstory

This may help to better understand my perspective and why it is of foremost importance to the Alpha to Omega paradigm. My journey began in June 1977 when I was twenty-two years old. I was driving home from my girlfriend's house just thinking about random things as most people do. Suddenly, a rapid train of thought began, which inspired my zealous vocal recognition – "there really is a God." I had already known there is a God and without question. I was raised a devout Catholic, but this was entirely more profound. Thoughts escalated rapidly while thrusting me into a stupor, for lack of a better word.

Instantly, a continuous barrage of information was flooding my mind and being processed at a single moment with clarity and understanding. It was as though thousands of things were new or redefined – a reset if you will. When the event was over, which seemed to be less than a minute, I was extremely overwhelmed. My heart was beating rapidly, especially when realizing I had driven over seven miles without cognizance.

Fear was absent but instead, an instant rebirth emerged with unprecedented wonder and insatiable curiosity in the light of a blessed bestowal. And to this day, my words cannot effectively translate the experience. If you haven't experienced anything like this, then there will never be an effective explanation for you to fully understand.

In the initial days, my curiosity was really peaking. I was feeling a sense of urgency as premonitions of a world calamity remained at the top of the immeasurable thoughts and concerns. In spite of these blurred visions of chaos and death, my faith became stronger than ever. I was confident of the ultimate peace that waits on the other side.

As the days went on, I couldn't settle down. I was constantly trying to explain the experience to my friends and family and stressing Christ's principles, redemption, and

return – but with a more exclusive inspiration. I was on cloud nine and I wanted my friends and family to feel the same way. It's like telling someone how you feel, and they say, "I know," and yet they were never on the same page.

It didn't take long before I stopped trying to influence anyone – especially my family. To them I was a broken record. In hindsight, it was foolish to expect anyone to really grasp what I had realized on that eventful day, but I surely tried to explain, and many times over.

During a period of six months, I had left the Catholic church, which no longer connected with me. I would read the same scriptures, which I had been previously taught, only to find a fuller meaning. It seemed as though I was a third person when reading biblical scriptures, if that makes any sense. Up to that point I had been deluged with Catholic rituals and repetitive narratives, which no longer satisfied my sudden insatiable curiosity. I felt as though something was seriously missing or misunderstood.

Yet, no matter how many different Christian churches to which I inquired, there were always varying rules and rituals. I knew what they were preaching because I had spent my entire short life listening to narratives defining the scripture. There had to be something more. As time went on, most religions were cult-like – all members following procedures. I didn't want rituals. I wanted the Truth.

Many hidden truths are often unobserved not invisible –

Everyone is far short of the knowledge of God. Seek and you shall find, knock and it will be opened to you. Why? Because God is All-Truth, and sin is the inherent failure to know All-Truth. Therefore, the Truth can only unite us, but beliefs can divide everyone. And where do those beliefs originate? I cannot tell you how many times I asked myself that same question in my relentless search. The answer was always the same. Somebody taught me.

From that day forward, I was determined to find the Truth and accept only that which I would discover with the Spiritual guidance within me. My faith was strong enough to take that step. The book of Revelation quickly became my top priority. I figured that if I could decipher it or understand it fully then I'd be more informed. I wanted to know what it all meant, and I quickly became enlisted to discover.

I had many questions and over time they were being answered – either by reading or stumbling upon information, conversation, and media or insights. My search to understand the end-times surprisingly helped me to unravel the past. I was slowly connecting past and future together, bits at a time. It became obvious to me that the past and the future are [inseparable](#), which had become a large part of my experience and led to greater insights.

New concepts for the popular biblical icons and specific scriptures had surfaced during the years-long process. I began reading pertinent information with much introspection and compiling extensive handwritten notes, which I still possess. There was much missing at that time, but there were two crucial points revealed to me on which I had stood firmly since 1983.

First things first. I never believed the notion that our world is six thousand years old as presented by most evangelical Christian churches. It's a ridiculous narrative. I also couldn't accept the notion that a boat could stay afloat during a violent and complete world extinction. The churches have posited this story and have been telling the same story for over 2500 years. It didn't make common sense to me any longer. I needed to make sense of it all for myself. Yet, my undying faith in the Christ grew stronger because I believed His Spirit had awakened me.

My earliest discovery was the Great Pyramid of Giza. I had no prior knowledge of it except for the notion that Egyptians built it for a Pharaoh. I learned that in school, so it must be true, right? After reading mounds of information on the Great Pyramid in the late seventies, I was amazed beyond belief. It is much more than just a remarkable anomaly. Learning about its countless features, size, and utmost complexity, led me to insist that it could not have been constructed at ANY time in our history – in spite of the continuing narratives that insult one's intelligence.

Holding to that contention kept my mind open as to how it could have been done and where it came from. My earliest and most prominent insight was that the Great Pyramid was actually Noah's Ark. I envisioned the Great Pyramid as more of a device – an arc like an electrical arc – like a rainbow – that bridged the gap between two points in time and two completely different civilizations.

The thought came to mind as an incredible idea, so I questioned myself regarding this notion. How could this be? I was certain that Noah's Ark was not a boat or a ship. It was an Ark, but what is an ark? Do you recall ever relating a boat or huge ship to an "ark" anywhere else?

Reliable answers started pouring in. My heart was beating rapidly – just like that eventful day – as I recalled the Genesis story's clear indication that people of pre-flood times lived nearly one thousand years. However, a closer look indicates the lifespans of post-flood survivors to be 800-900 years while clearly noting they were living amongst people with lifespans less than one hundred years.

So, at this point I began to insert the implications of my deduction, which are particularly important in this brief. The previous civilization must have been highly advanced and those

who survived were a separate seed from those of the post-flood era. A highly advanced society – far removed from our epoch – built the Great Pyramid. Are you aware that, in the end, we shall live for a thousand years? That’s the Alpha and Omega – a highly advanced God-centered society.

Many questions emerged from this premise, but at that moment, it became completely clear to me that the survivors of the highly advanced civilization – including Noah and his family – must be the sole explanation for the mythical gods found in ancient lore of Egypt, Greece, Rome, Mesoamerica, South America and everywhere in between. These became the pillars of my approach dating back to the birth of my son in 1983.

This is what is known as top-down thinking. Start at the top and continue downward. If you reach a point where the emerging questions cannot be answered, then your initial premise is invalid. My conclusion was based on the fact that names of the wives of Noah, Shem, Ham, and Japeth nor any female offspring or spouse can be found throughout the recorded lineage.

The eighties were a very difficult time for me. I had compiled quite a few notes, but I didn’t have time to go much further in reviewing them. I would write new ideas down and research some of them, but time was very valuable for me in those years, but I was constantly looking for answers along the way. I also created a lot of curiosity in the many discussions with others.

As the nineties arrived, things became more tranquil. I returned to further reading, writing and introspection. It’s important to mention my first book – Heretical Wisdom: The Truths from Within – published in 2001 (279 pp.). It is fairly organized, and there are many things I proffered without proof. There are no references to anyone in it. It is basically a conglomeration of my thoughts, ideas and conclusions. It is somewhat congruent, and it took me three years to complete. Writing it was an accomplishment, especially while holding a full-time job.

The premises are exactly the same. Noah’s Ark was the Great Pyramid, and the survivors (gods) were the teachers of the new epoch, which I labeled as “gods of the ignorant.” It culminated with very similar explanations for the Christ and the end days, which remain in Alpha to Omega. My unique paradigm was published. It was my first compilation of more than 15,000 words.

Here are some memorable quotes from Heretical Wisdom:

Today, the abundance of scientific knowledge and technology anesthetizes our wisdom by encouraging our contentment and stifling our curiosity.

In the absence of enlightenment, belief reigns above truth, masking our ignorance and producing our conflicts.

Our confusions are caused by the creation of a god in our own image, the insufficient use of our wisdom, our blind adherence to dogmatic principles, and our failure to see the light that has already been shed.

Our directives will soon be changed by the course of human events that will reflect our inherent ignorance, our incessant will to survive, and the undying struggle for truth without conflict.

In Heretical Wisdom, I noted the Sphinx, Machu Picchu, Nan Madol, Stonehenge, Nazca Lines and Tiahuanaco as examples of remarkable post-flood anomalies, which supported my hypothesis concerning the survivor gods. I also wrote about the Great Pyramid and its unique qualities in a simple 3-page overview.

The Alpha

From the late eighties onward, I associated all gods of ancient lore as a lineage of predecessors in the new epoch of humanity after the flood. They were no longer myths to me. The conclusion provides recognition of the female gods of ancient lore while expanding the numbers of these magnificent men and women.

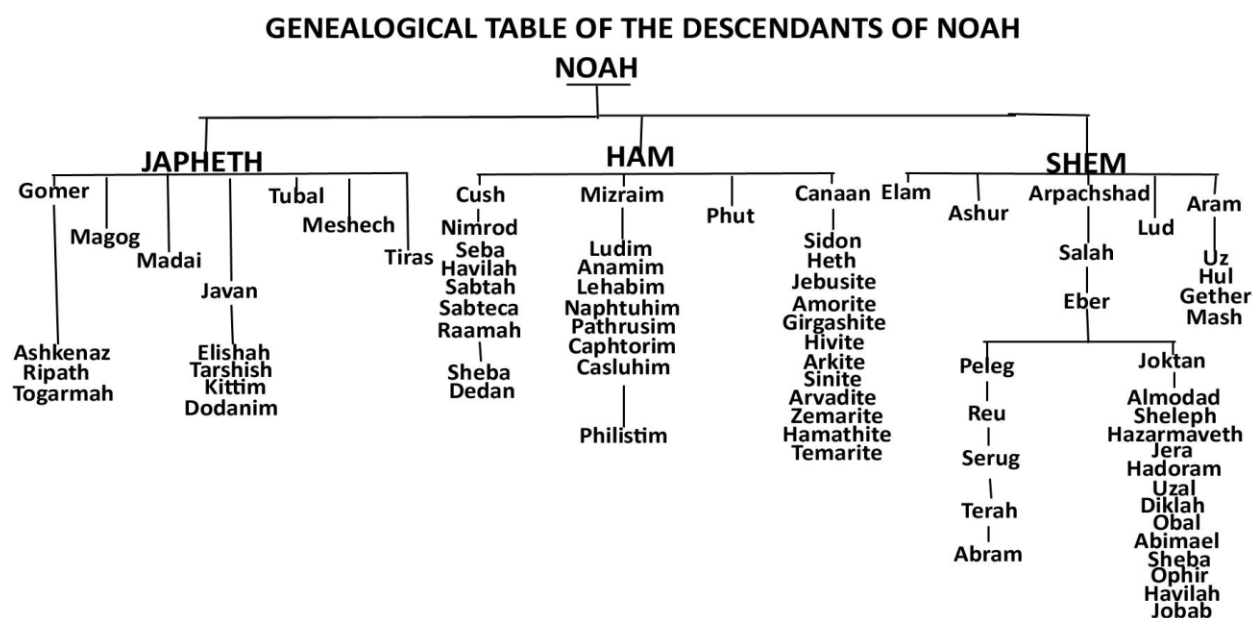
Genesis isn't the only flood legend. Back in the late eighty's I had discovered that there are well over three hundred deluge legends interwoven with "mythical" gods. These tales originated all over the world and were written long before influence from other regions. There are more than twenty-five clearly written pantheons of ancient lore and each derived in their own regions all over the world. This evidence was enough to support my conclusions.

Religious precepts didn't consider Noah and family to be gods. Curiously, the book of Genesis clearly spells out the nearly one thousand year lifespan of Noah and merely a few others. But by looking closer we find nations and regions named after them, which indicates very lengthy periods of time and honor.

In my later inquiries, I stumbled upon Arthur Custance Ph.D., an amazing man whose writings in the "Doorway Papers Series" helps to support this conclusion. The **unrecognized** pantheon is the Table of Nations – a lineage of Noah and his family and their offspring – many of whose names were used for countries and regions in establishing the eastern hemisphere. It is unrecognized because the religious guidelines denied "false gods" and thus the names of gods were purely mythical.

Notably, the names in the Table of Nations could very well be referred to as different names in a different Pantheon. One example known for sure is Iapetos, or Iapetus – one of the mighty ones in the Greek pantheon – whose name appears as a translation for Japheth. The Greek alphabet does not contain the letter “J” and substitutes the letter “I” for “J.”

The names in the bible may have been the result of the writers’ decision to include the names of gods from the tales in their region. Learning the history of Israel can be a story in and of itself. The table is a minimized patriarchal approach to history, which proves the systemic faults and their influence on history itself.



The Table of Nations can now be considered a King list. Never before has anyone considered that notion – not even Mr. Custance. It’s much like the Palermo Stone, Turin Papyrus, Abydos King list, Sumerian King list and others. But let’s not concede these to be the only lists because ancient lore includes the Greek Pantheon, Roman Pantheon, Egyptian Pantheon, and a score more. Could all of them be part of the same tree of survivors? Yes, that is my clear position in Alpha to Omega.

Noah bears remarkable resemblance to the similar gods of ancient Mesopotamian lore. Utnapishtim, Zisudra, Xisuthros and Atrahasis. In Hindu mythology, Manu is a righteous

man who is warned by the god Vishnu (in the form of a fish) about an impending flood and is instructed to build a vessel to save himself and the seeds of life, mirroring Noah's story. Deucalion and his wife Pyrrha are the only humans to survive a flood in Greek mythology, and they repopulate the earth by throwing stones behind them which turn into people, sharing a similar theme of renewal after a cataclysmic event.

Legendary folklore like this exists for one reason only – they are shattered tales that survived the eons of time because of their crucial significance to the origin of our species. There was one Great Flood and one Great Patriarch of the new age. Noah is the central figure and is revered in all of the myths of Mesopotamia, India, Greece, Central and South America. This is not a coincidence.

It's also quite fitting that Custance demonstrates how five major cultural centers began the expanse of the ancient world. Egypt, Sumer, and the Indus Valley are obvious locations because this is where history, as I had been **taught**, originated. Interestingly, he includes a swath of North America and the northern part of South America as well. He offers evidence proving each of these locations to be Hamitic in origin.

In this Table, we again meet with three groups of people, the descendants of Shem, Ham, and Japheth...So then, we have the Japhethites who can be conveniently equated for our purposes with the Caucasians, Indo-Europeans, or White Man; the Hamites who are held to encompass the Negroid and Mongoloid branches, and the Shemites who comprise both the Hebrew people (ancient and modern), the Arabs, and a few once powerful nations, such as the Assyrians and Babylonians.¹⁸

A survey of history with this thought in mind, applied to nations or races rather than to individuals, reveals that Japhethites have originated the great philosophical systems; the Shemitic peoples, the great religious systems whether true or false; and, surprising as it may seem to one not familiar with the evidence, the Hamitic people have supplied the world with the basis of almost every technological advance.¹⁹

Thus, it has come about that the pioneering task of opening up the world, subduing it, and rendering it habitable, was first undertaken by the descendants of Ham. This seems to have been done under divine pressure, for in a remarkably short time the children of Ham had established beachheads of settlement in every part of the world.²¹

Mr. Custance believed that all of this happened in a short period of time due to his faith in religious teachings. His stance on that matter is the reason he wasn't awarded his Ph.D. in anthropology. From an anthropologist's point of view, these offerings couldn't fit in a world where discoveries of Neanderthals and Cro-Magnons date back to 200,000 years. However, his discoveries and evidence to support them are prominent in spite of himself. He holds multiple master's degrees and a Ph.D. in philosophy.

What Custance believes to have occurred in only a few centuries, I posit as gradual advancements and interbreeding during more than 200,000 years of human development throughout the world. This is important because Alpha to Omega agrees with Custance and holds firm that people existed in the Western Hemisphere long before the land-bridge assumption.

The reason that begged my contention is in the tales of the Inca and Aztec gods – Viracocha and Quetzalcoatl, whose reported characteristics curiously resemble that of Noah. In both cases, Quetzalcoatl and Viracocha are Indigenous gods that are described as bearded and fair-skinned. Viracocha is the Incan god of the sun and storms, also known as the White God, Kukulcan, and Gucumat. Quetzalcoatl is the Aztec god of love, fair-skinned, fair-haired, with a beard, and wearing long robes. From the book of Enoch, we have Noah:

And his body was white as snow and red as the blooming of a rose, and the hair of his head and his long locks were white as wool, and his eyes beautiful. And when he opened his eyes, he lit up the whole house like the sun, and the whole house was very bright. And thereupon he arose in the hands of the midwife, opened his mouth, and conversed with the Lord of righteousness.³⁰ (*Alpha to Omega*, p 157 ref, *The book of Enoch, Complete Edition*, p. 122)

In Graham Hancock's America Before – the Key to a Lost Civilization (2019) he posits that newer evidence shows man to have been in the Americas some 130,000 years ago. I haven't read America Before, but I found it to be dubious at best. He wanted to assert that gods were in the Western Hemisphere and used Magicians of the Gods as his evidence!

Evidence of human habitation in the Americas that predates the land bridge tenet does exist. Yet there is not an accepted universal theory that explains this earlier evidence of humans in the Americas. Graham provided his theory in Magicians of the Gods as the explanation. Wait! It was really the premise of Alpha to Omega.

In both [Alpha to Omega](#) and my brief on [Atlantis](#), I explain why Solon's 600 BC report to Egypt regarding a flood that occurred 9000 years prior wasn't accurate (from Alpha to Omega pp.25-6):

In 600 BC everyone believed the world was flat and anyone who ventured beyond the Pillars of Hercules—or straits of Gibraltar—would fall off the earth. The Egyptian conceptual view of the world was obviously quite limited when Solon was granted the privilege to learn of the revered information. It's highly probable that 10,000 BC was far enough in history to support Egyptian belief in a previous society, which was destroyed, and the beginning of a new one. Scientific knowledge wasn't ample enough to reveal the time conflict, which is apparent today.

Interestingly though, when we posit that Atlantis represents a completely different civilization on earth much further removed in time than our preconceived notions dictate, we will find the evidence for it already exists and why our precepts are preventing us from solving the mystery. Atlantis thrived millions of years ago and a pole-shift in late Tertiary time was responsible for their demise:

Somewhere in late Tertiary time (4-7 million years ago), the relative positions of continents to the position of the Earth's poles shifted from sites in eastern Siberia and in the Southern Indian Ocean to their present positions. With the South Pole relocated in the great mountainous Antarctic continent, a series of important events began. First, precipitation in the mountains turned to snow then ice; snowfields built up in the glaciers and, growing larger, the glaciers spread out over the low lands. The freezing of Antarctica began about 3 or 4 million years ago and initiated a drop in the world's sea level because water was not returned to the oceans by the normal melting in the summertime (Columbia University, Columbia History of the World, Harper and Row, NY 1972, p18) Ref. p.25-26 Alpha to Omega - Journey to the end of Time

My contention throughout the years has always been that the previous society on earth had to be much further in the past in order to answer all the questions. It's also very curious to notice how such an adorned University as Columbia fails to mention this discovery any longer. I'm still in possession of the 1972 edition.

In many historic artifacts and renderings there are valid translations that these gods ruled for periods exceeding 25,000 years and in many cases 240,000 years and more. I stand by the elongated version because the central core of most flood legends is the eradication of

everyone on earth. If so, then I must account for the scientific evidence of Cro-Magnons and Neanderthals – each exhibiting social skills – that show up in archaeology as far back as 200,000 years ago, in the post-flood era.

How can we account for the hundreds of thousands of years that had transpired long before writing began? Alpha to Omega solves the conundrum via the Tower of Babel legend. Note that the legend isn't just a Genesis story. There are similar tales from around the world including the Americas and Mesoamerica with the exact theme. Look it up!

The earliest writings of mankind emerged around 3500 BC, most of them with tales of gods and flood-legends that destroyed the world. Prior to that there was nothing but countless verbal tales of the same themes for many thousands of years. What was the reason? Where did they acquire the notions of gods and their names with such similarity and veracity throughout the world after such a prolonged period of time before writing began?

Considering that the post-flood gods lived for nearly nine hundred years and people of the new epoch lived for ninety years, the same gods were present for over forty-five generations of the people in a region. Each family member is born and so are their children and their children forty-five times over. Obviously, something of that magnitude would cement the ancient oral traditions passed down through generations. It continued for thousands of years as mankind continued to grow in population all over the world.

My contention is that the Tower is representative of all the amazing megaliths and structures discovered throughout the world. I conclude that the magnificently structured megaliths found throughout the world are undoubtedly a product of a highly advanced form of metaphysics.

These megaliths were not remnants from the previous civilization, but a product of the gods – survivors of the previous civilization – coupled with people of this epoch, to utilize collective telepathy (**one language**) and telekinesis to form, mold, lift and construct these gigantic and unexplainable megaliths for over thousands of years. It's easy to understand the long-term effects of these indelible impressions.

This is why the amazing similarity in themes of oral tradition for thousands of years across the world long before writing emerged. In those days, gods were real – not myths. These are the reasons for gods found so deeply embedded in the earliest written historical records, which emerged thousands of years later. Questions emerge from my conclusion, which are explained in Alpha to Omega.

Something worth noting is that the megaliths were built with stone, which cannot be carbon-dated, while curiously eliminating the abuse or destruction of the ecosystem. And, strangely enough, people had not yet been taught to write. Why?

The sudden impetus to write and communicate with other regions was purposely imposed when the gods removed the metaphysical abilities as explained in the Tower of Babel legend. This certainly helps to explain why the earliest writings from around the globe were exploding with similar themes of gods and flood legends. It's also important to recognize the instant result of major confusions when varying regions with different languages were trying to communicate with each other – during the most primitive period of writing!

Genesis was written during the reign and within the Persian empire. Leaders had agendas. Alpha to Omega reveals in detail the Pentateuch having been accepted as the first chronicle of history. It was utilized as a means to quell the divisiveness based on differing and long-held verbal tales of gods and flood legends. Here is an excerpt from Alpha to Omega that sheds more light on the subject: [The History of History](#).

Metaphysics

My argument is firm. If you cannot visualize or understand the power of metaphysics, then you won't understand the miracles of Christ. *"Truly I tell you unless you turn and become like these children, you will never enter the kingdom of heaven.* (Matthew 18: 3). To understand a child, we simply know that as an infant we are tied only to true Spirit at birth. There are no concepts, no expectations, no time, colors, definitions or shapes. Everything in the child's reality is fluid.

The infant has the total power to shape and form reality into anything so desired. But the child doesn't know that. To become a Master, you must dedicate your life to finding your way back to birth when everything was fluid. Only then are you totally connected to Spirit – the Essence – and you can shape the fluid world in any way you wish. To become like little children is to return to a place of pure love, non-judgement and a world where everything is possible.

To understand the survivor gods, and most important, the dangerous path to our ultimate destiny we can see how this power can be misused. Likewise, we can begin to see the varying level of powers from human beings to Supreme Beings – which is the highest level of material achievement.

Noah and survivors were only one step removed from perfection. How do you explain their demise while bearing such power and intelligence? How do you explain their survival? How do you explain UFO's? How do you explain angels? More importantly, how can you explain the book of Revelation? These are questions that most people have never thought to ask but are clearly answered in Alpha to Omega.

Alpha to Omega reveals discrepancies in both the scientific and religious arenas by proposing unprecedented perspectives for consideration. The process leads to a deeper and more meaningful approach to the life and times of Christ by removing the mask of religious rhetoric. His baptism and succeeding miracles and an extraordinary perspective of His final trek into the desert and His face-off with Lucifer ties the past together with His purpose and harrowing final decision.

Further on, Alpha to Omega provides the evidence of the Roman Empire's siege of Christianity – all for the sake of the Empire and after murdering countless numbers of Gnostics for hundreds of years. They were the true Christians and the heart of the first churches in the region. When the Spirit entered them as Christ promised, they were able to see things (gnosis) which they died for, rather than give up their witness to Truth. Power begets power not Truth.

I think it's important to mention the systemic faults of our world. Leaders write history; secrets are withheld; time erodes interpretations; some things are edited or removed over time; and all of it is written to support the changing narratives that uphold the institutions. Are we supposed to eliminate the systemic faults of human nature in our evaluations?

We can now look closely at the Great Pyramid, which aides to understand the "Timeless Essence" of all life – God. Detailed explanations in Alpha to Omega explain the Great Pyramid as a timeless device and the Tree of Life. The missing *capstone to the endeavor* is speculated as – The Ark of the Covenant – the final, most significant achievement in such a remarkable project.

By examining the recorded traits of the Ark of the Covenant, we recognize the Cherubim on the mercy seat. We also see, "...The Cherubim that turns every way to guard the Tree of Life..." (Genesis 3:24). Alpha to Omega explains the Great Pyramid to be both the "Arc" and the Tree of Life in a new age removed in time by nearly four million years as we perceive it.

Further we discover the Essence of God (p.55 Alpha to Omega reference: Urantia Book, Universal Father p.25:

No material man could behold the spirit God and preserve his mortal existence. The glory and the spiritual brilliance of the divine personality presence is impossible of approach by the **lower groups** of spirit beings,

or by any order of material personalities. The *spiritual luminosity* of the Father's personal presence is a light which no mortal man can approach, which no material creature has seen or can see. But it is not necessary to see God with the eyes of the flesh in order to discern him by the faith-vision of the spiritualized mind.⁶

We also see the higher angels and their **luminosity**: The Encyclopedia of Angels 2nd edition – Rosemary Ellen Guiley Ph.D. (p.75 Alpha to Omega reference)

The upper triad is composed of SERAPHIM (love), CHERUBIM (knowledge), and THRONES, all of whom are in **direct contact** with God. They receive “the primal theophanies and perfections.” **These three levels are so close to God as to be perfect and utterly pure**: “they are full of a superior light beyond any knowledge and are filled with a transcendent and triply luminous contemplation of the one who is the cause and the source of all beauty.”¹⁵

And this is from the Urantia Book, Divine Counselor p.10: (p. 76 Alpha to Omega)

Light—*spirit luminosity*—is a word, symbol, a figure of speech, which connotes the personality manifestation characteristic of spirit beings of diverse orders. This luminous emanation is in no respect related either to intellectual insight or to physical light manifestations.¹⁷

The Arc was a timeless device, which served as both a life-creation catalyst and the suspension of time for those who had crossed the four million year gap. It is the only evidence needed to solve the many mysteries of Egypt – even those which have not yet been uncovered. Alpha to Omega demonstrates Egypt as the headquarters of the new world and answers the many questions that emerge from these solutions.

When I discuss time, I see that it can only exist in the realm of imperfection. The Great Pyramid had to be perfect in every way to be a timeless device. Try to visualize that everything outside of Nature begins as an illusion or vision in someone's mind. The process is that we create things by manipulating energy and matter over time with processes and tools that have also been developed by the mind over time. It's mind (Meta) to matter (physics) in a matter of time. It's metaphysics at the lowest level.

Over the many years we have remarkably reduced the amount of time it takes to make things. Here we see that, as we progress, time is reduced in our creations. We can easily extrapolate that to a perfect world where thought and creation are simultaneous – which is the very Nature of God – the Infinite Mind – Timeless.

Metaphysics and Revelation

In 2013 I published my 5-volume e-book series, [Apocalypse Now](#). Each short volume emphasizes the prominent features of [Alpha to Omega](#). The first volume [The Metaphysics of Truth – Unobserved Realities and the Four Horsemen of the Apocalypse](#), is very important and is explained in depth through [The Metaphysics of Truth](#), a video I created in 2014. There are separate links to the video, but each one is the 2014 original.

[The Metaphysics of Truth](#) demonstrates Truth's incessant attempt to reveal itself through these experiences in our physical world. Unprecedented explanations for the Four Horsemen of the Apocalypse are explained in detail to reveal the underlying metaphysics of our existence. In simple terms each one has its own designation: (1) Truth; (2) belief; (3) the metaphysical balance between them; and (4) the current imperfect world of death suffering and confusion.

Understanding the past and the future led me to the discovery that they are inseparably bound by the cause and effect of our collective beliefs and the choices influenced by them. Today's world mirrors the obvious flaws and differences in our basic assumptions. If Paradise is a perfect world, then earthquakes, violent storms and meteors reflect a collectively confused world. We create them.

What does the book of Revelation reveal to us? It demonstrates the metaphysics of our existence – the effect of choices that arise by belief and the offsetting metaphysical effects of Truth's incessant nature to become manifest. An apocalypse is an awakening to Truth, either through the insights of our wisdom or the harsh experiences that enlighten us.

Philosophy is the heart of scientific inquiry. Truth is within – not without – because the Essence of Life – God – the Animator of Life is at the center of all life from the microcosm to the macrocosm. It manipulates matter and energy to create vehicles of life for the sole purpose of becoming **completely and perfectly** expressed in the physical world, which is exactly what the [Alpha and Omega](#) represent: Supreme Being.

Supreme Being is not to be misconstrued as God the Universal Father. A Supreme Being lives for one thousand years and is at the highest level of material existence – Paradise. There are ten steps of angels above this level and still beneath God the Universal Father.

The evolution theory is a ridiculous narrative. Science has been pushing this for almost two hundred years! Understanding the complexity of DNA and its unique properties for every living thing or organism is enough to realize that a horse didn't morph into a mule or a zebra. Only the Infinite Mind can create such spectacular diversity and beauty.

With the current evidence, it's impossible to consider such a ridiculous theory created by a man during the time when science had yet to discover DNA or to dissect the amazing properties of cells and the little animated machines – made of proteins – that constantly work throughout our bodies. Put Darwin's theory in a coffin.

Importantly, science knows for certain that evolution cannot be proven by any means because they cannot create life in a laboratory – not even a single cell organism – without a living organism to begin with. It's a puzzle and in the depths of hidden science is the attempt to find the Essence. The large hadron colliders are searching desperately.

The multiverse theory is complete nonsense. The myriad uncertainties observed at the quantum level have given rise to the Multiverse **theory**, which was proposed partly to dismiss the paradox of traveling to the past and changing the future. It was also presented as a solution for the myriad possibilities taking place in separate universes. There are so many theories, which are ONLY theories but are used to support added theories like the multiverse.

When science accepts theoretical models to support another theory, they often base new findings on unproven theories. This is known as non-empirical confirmation, which is simply the acceptance of non-empirical evidence to promote another theory. In science, it happens more than we know and yet science demands proof! So many people believe in time travel, and it has not been proven – not even close to being proven. How can you travel through something that only exists in an imperfect world? Oh, what tangled webs we weave.

In my video I demonstrate the mechanics working the same throughout the microcosm to the macrocosm, which provides a unique evaluation of the evidence of quantum mechanics. The myriad uncertainties observed at the quantum level are mirroring the myriad uncertainties of sentient choices made by anyone and everyone at any given moment.

Here's a simple example. If you decide to go shopping, you will include other decisions. The time you depart, the route you take and all of the in between decisions will occur along the way. When you get to your destination everyone you see walking throughout the store are NOT random connections, because everyone in that store is there at that point in time because of the choices they make. Anything that happened along the way, whether you witness it or become a part of it, is equally not random. **Nothing** is random or happenstance.

If you made different choices, the outcome would be completely different, but it doesn't mean that a multiverse exists as a provision for alternate possibilities in separate universes.

Our reality is quantum, but WE create it. It is not separate from us; it is we who create the quantum physical world – not the other way around.

Try to imagine God in every living being as a tiny drop of His endless ocean of Infinite Mind and Power. Can we prove how a decision by anyone can alter the outcome of our physical reality – even on the quantum level? It's always God in the works!

I believe the "observation paradox" is proof of this contention. The paradox refers to the phenomenon where the act of observing a quantum particle affects its state, causing it to collapse from a superposition of possibilities into a single, definite state. Even though scientists have tried to trick the experiment, the result remains the same.

This clearly demonstrates that the act of observation itself influences reality at the quantum level. I don't understand why scientists haven't considered observation, which is a result of choice, as proof that a person's decision affects and creates reality. They're still stuck on trying to figure out how quantum mechanics affect reality rather than how we create quantum reality. It's metaphysics – mind to matter – or to reality as we perceive it.

We create our own reality both individually and collectively. The multiverse theory evolved by trying to explain the results and implications of quantum mechanics, instead of considering quantum mechanics as the evidence of myriad possibilities of sentient choice. Perhaps their narratives are deliberately confusing us as they delve into things we are not privy to.

These metaphysical powers create everything in our physical world. A simple experience – good or bad – and everything else, including the Natural events throughout the world, are created by the actions and decisions based on belief or Truth. Nothing is random or happenstance. The connection between past and future can never be broken in the realm of sentient beings. The Truth is always trying to reveal itself.

Currently, the delicate metaphysical balance between the power of Truth and belief keeps the world on its current path where death, sickness, happiness, sadness, and suffering remain, but the balance between Truth and belief is going to become askew. Alpha to Omega is also a warning to understand the sixth seal in the book of Revelation – the harbinger to the end of days. What will we be faced with?

Keep in mind that human potential is a more-than-ample alternative to the ancient alien theory, while putting 'aliens' in their place. When we understand and discover our human potential, we will stop looking outside ourselves for answers. If you think that ETs are here to help us maybe you should ask a few questions. What do they have that we don't? Who

are they? Are they here to help us? They could have brought us to light a long time ago. What does that imply? What will you do if they come to our aid in a much needed time?

These points and more are discussed in [Alpha to Omega](#). Human potential must be stressed to understand the varying levels of knowledge and power. The argument is discussed in [Alpha to Omega](#) and further expanded here in an elongated brief: [UFO's – Discovering Ourselves, Reality and the Cosmic Battle](#).

Hancock claims that the Younger Dryas period was our last ice age. Ice has advanced and retreated many times in the Quaternary Ice Age, which began between two to three million years ago. In fact, there were earlier times during the Quaternary Ice Age when ice covered sixty percent of the earth. An advance that covers the land that far south in the Americas can easily explain the many carved out canyons that Hancock attributes to rushing waters.

I'm sure the Graham knows this and while he's trying to prove his case to the academia, he now goes through extensive efforts to prove that a flood was caused by a comet during the Younger Dryas and that these "gods" were from the preceding era of an advanced society. He is clearly relating it to the many ancient texts of the great flood including Genesis.

Does that give him the right to plagiarize a pillar of my work, which is more important to me than anything else? Especially without any recognition whatsoever! I suppose that Mr. Hancock doesn't realize the detour he has created for me and the amount of disrespect he has demonstrated by an author of his caliber.

He usurped my published and extremely important intellectual property as a solution for his new dead-end theory. My long duration of discovery has always been very sacred to me. I ask you to be honest. The truth is that I was the first to publish a solution for the mythical gods. In this brief I hope you can see the importance of the discovery and how more meaningful it really is.

Whether or not I have many challenges to his theory doesn't matter. The fact that he plagiarized my entire foundation should be all that is considered. If he is allowed to continue then he will obviously encroach on other things as he has already tried. He is eventually going to be forced to answer the questions I have already answered.

Specifically, he had proposed a solution for lifting heavy rocks with acoustics and was questioned by Piers Morgan in a recent interview. He denied the claim and **blamed** one of his researchers, while showing signs of embarrassment. He knows he will need an explanation. How long will it take before he looks into the metaphysical forum? Have I created a book for him to use as an outline for his own investigations and continued plagiary?

As I mentioned earlier, philosophy is the heart of science. A premise must have a conclusion that melds everything together. Graham Hancock is not concerned about the future. He's become an ego-centric researcher. He is at a dead-end without substance as he exploits his followers and throws me to the curb.

My results may be different, but it really doesn't matter. The important aspect is whether or not a legal team will recognize my work as well-thought, well-researched and thus a victim of Graham Hancock's malfeasance.

Philosophy is the only way to answer these questions and there must be a means to an end. Alpha to Omega satisfies that requirement and this one also:

A philosophy that does not culminate in a metaphysic of ecstasy is vain speculation. –
